ESEA Reauthorization!!!

There has been a great deal of activity regarding ESEA reauthorization since the November elections. On January 14, 2015, Senator Alexander, new Chair of the Senate HELP Committee, released his ESEA Reauthorization Discussion Draft. Several hearings have been held and Chairman Alexander and Ranking Member, Patty Murray (D), have agreed to work together to reach a bipartisan agreement on the Senate version.

On the House side, Chairman Kline, returning Chair of the House Education and Workforce Committee, introduced the House ESEA Reauthorization bill (HR5) on February 3, 2015. Eight days later, the bill went through markup and was voted out of the House education committee on a partisan vote. HR5 is expected to be put to a vote by the full House early next week so please watch out for an action alert from CQ Engage asking you to contact your Congressperson and urge them to vote yes for HR5.

Both education chairs are anxious and optimistic about obtaining floor time before the full Senate and House, and then conferencing the bills and eventually sending a bill for signature to the President's desk. It's not a slam dunk by any means, but there are reasons to be optimistic. First, both the House and the Senate have taken action within the first month of the new Congress. Last year, only the House took action. Second, the Secretariat of Catholic Education has been in full advocacy mode since before Christmas. Because of these early meetings, we were able to make substantial progress in improving the bills so as to restore private school's full and fair equitable participation under ESEA's Title I and Title II programs. Third, our advocacy includes direct input from all of you at the local level-the constituents. On January 29th (during National Catholic Schools Week), we coordinated a full day of Hill visits for the Superintendents and Government Programs staff from the Archdiocese of Baltimore, Archdiocese of Washington, and the Diocese of Arlington. A big thank you to Barbara Edmondson, Kelly Branaman, Sister Bernadette McManigal and Diane Elliott who were all outstanding in explaining and presenting the issues, concerns, and suggested fixes in the ESEA reauthorization.



On February 12, 2015, we conducted a second full day of ESEA Hill visits for Superintendents and Associate/Assistant Superintendents from Chicago, Los Angeles, Miami, New York, and Seattle, as well as a representative from NCEA. We were also joined by the State Catholic Conference Director of Indiana and the Director for Education at the New York Catholic Conference. Once again our Catholic leaders did a fantastic job of advocacy clearly illustrating the challenges that Catholic schools face with ESEA at the local level. On February 9th, Senator Tim Scott hosted a School Choice Forum event for the Senate. Sister John Mary Fleming, our Executive Director for the USCCB Secretariat of Catholic Education was one of the panelists. Here's a link to the video from the event.
