

Criteria for Sponsorship:

- Sponsors, whether commercial or non-profit, offer services or products compatible with the mission of CSMG and the teaching of the Catholic Church.
- Only organizations or corporations may be sponsors, not individuals.
- CSMG reserves the right to limit the total number of sponsors and must approve sponsors in writing.
- Sponsor's acceptance of CSMG's terms and conditions will be indicated by the signing and submission of the Sponsorship Pledge Form.
- Sponsors must submit financial contributions in full no later than **November 15, 2024**. This amount is non-refundable unless unforeseen factors result in the cancellation of the entire event.

Sponsorship Terms and Conditions:

- Sponsors must wear sponsor badges at all times during CSMG events.
- Sponsors may display materials only in approved locations.
- Sponsors approved to distribute materials at CSMG must submit such materials to CSMG staff in adequate quantity no later than December 31, 2024.
- Due to USCCB policy, sponsorship of CSMG does not include registration for CSMG programs or events or any of the pre-Gathering or collaborating organization events associated with CSMG. Sponsors are welcome to register separately to participate in CSMG or for pre-Gathering events.
- Any sponsors exhibiting at CSMG 2025 are subject to the Exhibitor Terms and Conditions.
- Additional terms and conditions may be specified by CSMG staff.
- Sponsorship can be shared by no more than 2 organizations, and both organizations must abide by all sponsorship terms and conditions.

Key Dates for Sponsors:

- **November 15, 2024 –** deadline for receipt of pledge forms and financial contributions to be included on the conference virtual platform.
- **December 31, 2024** final deadline for receipt of organizational logo, website, video (if applicable), and presentation outline and slides (if applicable). *Please note that USCCB General Counsel requires a review of sponsor materials in order to ensure that content abides by legal requirements and other necessary approvals (see next page).*

Sponsor Contribution Instructions:

Prospective sponsors are asked to return the enclosed Sponsor Pledge Form as soon as possible to ensure
maximum visibility in CSMG 2025 promotion and reference materials. CSMG staff will respond confirming the
availability of sponsorship for events, confirming arrangements, and providing an invoice for contributions.



• Corporate sponsorships are an important source of support for the USCCB's mission to promote the Gospel of Christ and the teachings of his Church. We ask that all sponsors of the 2025 Catholic Social Ministry Gathering follow USCCB corporate sponsorship policies. Therefore, sponsors may not use qualitative or comparative language in any sponsorship messages or otherwise endorse or induce to purchase, sell, or use a sponsor's products or services, and may not provide price information or other indications of savings or value. In addition, the sponsor hereby agrees to adhere to the following guidelines when (1) preparing their pre-recorded presentation; (2) sponsoring an event that is part of the conference program; and (3) offering a pre-program or post-program event.

USCCB Permits the Sponsor to Do the Following:

- Include the sponsor's name, logo, phone number, locations, Internet address, and slogan (if the slogan is an established part of the sponsor's identity) on any handouts, posters, etc.
- Disseminate a message (verbally or visually) with its acknowledgment regarding the event, subject to the limitations and Required Language Concerning USCCB Sponsorship Policy, below.
- Include or discuss value-neutral displays of the sponsor's products or services on any handouts/posters or during any discussion.
- Include a single website link (e.g., depicted by a sponsor's logo) that takes the user to the sponsor's home page (not to marketing information or to a particular product or service) on any handouts/posters.

USCCB Prohibits the Sponsor from Doing the Following:

- Advertising of any kind, including any message which promotes or markets any service, facility, or product, or which contains qualitative or comparative language, price information, or other indications of savings or value, an endorsement, or an inducement to purchase, sell or use any company, service, facility, or product.
- Making any statement that the USCCB endorses a sponsor's products, services, or facilities.
- Providing privileges, goods, facilities, or services to the sponsor, including but not limited to complimentary tickets or registrations, preferred seating, meals, drinks, transportation, or other accommodations.
- Any language suggesting, directly or indirectly, that the sponsor has entered into an exclusive provider agreement with the USCCB.

Additional Language Related to Sponsors' Logos, Videos, and other Media Content:

• Sponsors hereby grant USCCB the royalty-free, non-exclusive right to use, reproduce, and distribute without limitation the short videos or other content such as but not exclusive of podcasts, audio books or other content delivery systems of Sponsors alone or as part of any USCCB video or other content such as but not exclusive of podcasts, audio books or other content delivery systems or in any other manner and media now known or subsequently developed, including but not limited to social media such as YouTube or USCCB's website or any affiliated websites. The term of the Permission of these materials is 10 years with the option to extend it for another 10 years, and the territory is worldwide. Sponsors expressly represent and warrant that they own or have valid licenses or authorizations to have the right to grant the Permission to USCCB. Sponsors further represent and warrant that they have obtained all necessary rights, licenses, grants, permissions, or other necessary approvals ("Third Party Approvals") from any third parties who may have rights in any portion or component of these short videos. At USCCB's request, Sponsors shall provide written documentation or evidence of having all such Third-Party Approvals. Sponsors also explicitly represent and warrant it owns the Sponsors' logos and any other trademarks, trade dress, trade names or related intellectual property and that there are no third-party claims or conflicts with respect to the foregoing.



Sponsors shall indemnify and hold harmless and defend at Sponsors' sole expense USCCB and its officers, employees, agents, affiliates, or representatives against any or all conflicts, claims, judgments, settlements, dispositions and/or actions of any nature or kind whatsoever arising from USCCB's use of any of the materials listed above or in this CSMG 2025 Sponsor Policies & Guidelines Kit, with no limitations or exclusions of any kind.
