Fran Raia, CPPS - The 2004 CPPS General Chapter mandated that leadership explore options for underutilized Motherhouse space. We entered into a partnership with a for profit developer to renovate the space into 60 senior apartments and renovate the skilled care area of 50 beds. Through the advice and consultation with experts we were able to license the entire facility.

1:30 Partnership: What do you look for in a partner and what are the legal pitfalls? What are the negotiables and non-negotiables?

Ms. Rosemary Corsetti – Ms. Corsetti will review the civil legal process of deciding on the best means of "partnering" with other organizations, whether that be from the congregational, provincial or ministry perspective. She will outline the best practices for such a project, projected timelines and the necessary approvals that may need to take place in this partnering process. Rosemary has served as in house general counsel to three national long term care chains, so she brings the operational expertise of how long term care actually works, and how the different type of long term care facilities may affect the partnering decision making process.

Sr. Doris Gottemoeller, RSM – I will focus on the experience of numerous joint ventures and collaborative efforts among and between religious institutes, focusing especially on the prior understandings and cultural elements which promote successful outcomes. What are some pitfalls to be avoided and some best practices to be adopted?

Dale Thompson – My experience/expertise will be in the arms of selecting a "Property Partner" / Negotiables and Non-Negotiable of the partnership, etc. I will offer information regarding two to three actual case studies of successful partnerships.
